	Maternity Protection Evaluation Interview	Daily working time max. 9 hours, weekly working time with employer max. 40 hours. Expectant mothers are not allowed to do any work e.g. heavy lifting and carrying and work under risk of accidents (see brochure "When expecting a baby"). Remuneration from employer averaged over the last 13 weeks.	
∞	Early Maternity Leave / Employment Ban	In the event of health problems, an early ban on employment may be imposed. A certificate from the Labour Inspectorate or a medical specialist or public health officer is required.
